

ORDINANCE NO. 1187

AN ORDINANCE AMENDING AND RESTATING THE SCHEDULE OF RATES AND CHARGES FOR THE TELL CITY ELECTRIC DEPARTMENT TO COMPLY WITH HOUSE ENROLLED ACT 1002

WHEREAS, the City of Tell City, Indiana, owns and operates a municipal electric utility known as the Tell City Electric Department for the purpose of distributing electric energy and providing energy related services to customer in and around the City of Tell City; and

WHEREAS, the Tell City Electric Department's existing schedule of rates and charges for electric services was established by Ordinance No. 1072 adopted on December 2, 2013; Ordinance No. 1122 adopted on April 3, 2017; Ordinance No. 1133 adopted on November 13, 2017; and Ordinance No. 1159 adopted on January 6, 2020; and

WHEREAS, on June 6, 2022, Michael Hicks, the General Manager of the Tell City Electric Department forwarded to the Common Council a copy of General Manager Order 220606 recommending that the Common Council adopt a new schedule of rates and charges (a copy of General Manager Order 220606 is attached hereto and incorporated herein as Exhibit "A") to comply with House Enrolled Act 1002, which repealed the Indiana Utility Receipts Tax; and

WHEREAS, the Common Council reincorporates the findings of Ordinance No. 1159 and FURTHER FINDS that rates set forth in Ordinance No. 1159 should be reduced for Tell City Electric Department customers across all tariffs by 1.4% to incorporate the repeal of the Utility Receipts Tax pursuant to the provisions of House Enrolled Act 1002.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Tell City, Indiana, as follows:


Section One. The schedule of rates and charges for the Tell City Electric Department should be reduced across all tariffs by 1.4% to reflect the repeal of the Utility Receipts Tax pursuant to the provisions of House Enrolled Act 1002.

Section Two. The Tell City Electric Department shall notify its customers across all tariffs in writing of the reduction of their electric bill in compliance with the provisions of House Enrolled Act 1002.


Section Three. This ordinance shall be in full force and effect from and after July 1, 2022

Section Four. In all other respects, Ordinance No. 1159 and its predecessors shall remain in full force and effect.





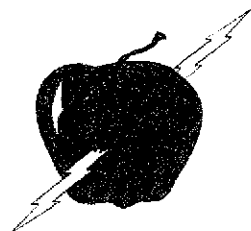
